### Call to Order

Mr. Congdon called the meeting to order at 7:04 p.m.

## **Announcements**

Mr. Congdon called for a roll call vote and the tally indicated the motion passed by a vote of 7 ayes, (Ms. Boyle, Mr. Congdon, Mrs. Hollenbach, Mr. Pirritano, Mr. Rudy, Mr. Sanna, and Mr. Sullivan) and 2 nays, (Mr. Feather and Mr. Morris.)

### **Public Comment**

Steve Rodos, retired, resident of Villages of Flowers Mill, commented that he would like to see the impasse with the NFT contract settled promptly. He said that money in the reserve funds can help to settle the impasse and teachers in the Neshaminy School District deserve a contract that stays in line with the already agreed upon salary schedule.

### 1) Motion: E-Signature with Pennsylvania Department of Education

**BE IT RESOLVED**, by authority of the Board of School Directors of the Neshaminy School District, and it is hereby resolved by authority of the same, that Joseph Jones III, who is the Superintendent of the above named body is authorized and directed to sign any and all contracts, agreements, grants and/or licenses (hereinafter collectively referred to as contract(s) with the Pennsylvania Department of Education (Department); and

**BE IT FURTHER RESOLVED**, that the body consents to the use of electronic signatures by the above named individual and that no handwritten signature from the above named individual shall be required in order for any contract with the Department to be legally enforceable and that by affixing his/her electronic signature to an electronic file of the contract via the Department's e-grants system, the above designated authorized individual shall have effectively executed and delivered the contract, binding the Neshaminy School District to comply with the terms of said contract; and

**BE IT FURTHER RESOLVED**, that no writing shall be required in order to make the contract valid and legally binding, provided that the Department and all other necessary Commonwealth approvers affix their signatures electronically and an electronically-printed copy of the Contract is e-mailed or is

otherwise made available to the body by electronic means; and

**BE IT FURTHER RESOLVED**, that the body will not to contest the due authorization, execution, delivery, validity or enforceability of the electronic Contract under the provisions of a statute of frauds or any other applicable law. The Contract, if introduced as evidence on paper in any judicial, arbitration,

**BE IT FURTHER RESOLVED**, that the body will notify the Department's Bureau of Management Services promptly in the event that the above named individual is no longer authorized to execute agreements on behalf of the body electronically and that the Department shall be entitled to rely upon the above named officer's authority to execute agreements electronically on behalf of the body until such notice is received by the Department's Office of Chief Counsel.

# 3) <u>Motion: Addendum to Extend Agreement - Source4Teachers</u>

This is an Addendum to an Agreement between **S4Teachers LLC**, d/b/a **Source4Teachers**, a Delaware limited liability company (the **"Company"**) located at 800 North Kings Highway, Suite 405, Cherry Hill, New Jersey 08034 and the **Neshaminy School District** (the **"District"**).

**Whereas,** the District and the Company entered into an Agreement whereby Company is to provide substitute staffing to fill positions at the request of the District for a period ending June 30, 2016;

**Whereas**, District and Company are desirous of extending the term of the Agreement through June 30, 2017 with the provisions set forth below;

**Now, Therefore**, be it agreed between the parties, as follows:

- 1. The Term of the Agreement, as reflected in Paragraph 7, is hereby extended to June 30, 2017;
- 2.Addendum "A" to the Agreement, Pricing, is amended as per the attached revised Addendum "A";
- 3. This Agreement will automatically renew for additional one (1) year periods unless either party provides written notice of termination at least ninety days prior to the end of the fiscal school year.
- 4. Except as specifically and explicitly set forth herein, all other terms of the Agreement shall remain in full force and effect.

# 4) <u>Motion: Edvocate - Consulting Services for Contract Monitoring & Compliance of the District's Food Service Program</u>

**NOW, THEREFORE, BE IT RESOLVED**, that the Business Administrator be authorized to execute the agreement upon review and approval of the Board Solicitor. The agreement provides for services for the sum of \$19,200.

### 2) Lease Agreement with Lower Southampton Elementary School & BCIU #22

Mr. Congdon read the following motion:

At the Regular Meeting of the Board of School Directors of the Neshaminy School District ("School District") for which Notice was duly given, held on the 16<sup>th</sup> day of August 2016 at the District Office – Boardroom of the Maple Point Middle School, 2250 Langhorne-Yardley Road, Langhorne, PA 19047, upon motion duly made and seconded,

IT IS RESOLVED that the School District enter into a Lease for the lease by the School District of that certain building and appurtenant tract of ground commonly known as the Lower Southampton Elementary School located at 7 School Lane, Lower Southampton Township, Bucks County, PA to Bucks County Intermediate Unit #22 for a Term of six (6) years and eleven (11) months commencing on August 1, 2016 for a base annual rent of \$222,384.00 for the first year of the Term with a rent escalator of three (3%) percent for each subsequent year of the Term, subject to the terms and conditions of the Lease which provides for the Lessee, at its sole expense, to make the improvements to the property described in the Lease. The final form of the Lease shall be approved by the Solicitor of the School District.

IT IS FURTHER RESOLVED, that the President, Vice President, Secretary, Treasurer and Solicitor of the School District are hereby authorized and directed on behalf of the School District, and under its Corporate Seal, to execute the Lease as approved by the Solicitor and such other documents and other affidavits, and to take such further action as may be required by law and necessary or desirable to effectuate the Lease and the intent of this Resolution.

#### **Public Comment**

Steve Rodos, retired, resident of Villages of Flowers Mills, continued his comments regarding the contract with the NFT. Mr. Rodos stated that Neshaminy teachers are working constantly for the benefit of the students and he pleaded with the Board to settle the contract and get on with life. He also mentioned that he has doubts whether the district is really saving any money by outsourcing the substitute teacher program. Mr. Rodos said that the district is paying 50% higher pay to Source for Teachers than what independent substitutes make.

### **Board Comment**

Mr. Morris called the action of the constable serving legal papers during the meeting a pure demonstration of political abuse and suggested that District Justice, John Waltman, is behind the legal action. Mr. Morris said this is an attempt to silence him. He also apologized to the public for the interruption to the meeting.

Mr. Pirritano welcomed Mr. Jones to the position of Neshaminy School District Superintendent. He stated that Neshaminy is a wonderful district and he looks forward to a productive school year ahead.

Mr. Congdon also welcomed Mr. Jones and said he is looking forward to making changes for the better and
