Neshaminy 60th Annual Summer School 2017

Secondary Summer School (Grades 6 - 12)



Neshaminy offers enrichment and remediation courses in various subjects to students in grades 6 -12. The course description on the following pages provides information about the offerings.

Summer Stock/Theater Workshop (Grades 3 - 12)

These are summer theatre workshops that include experiences in drama, music, dance and make-up, culminating in performances of Broadway musicals. These are four week courses, July 5, 2017 - July 30, 2017, and will be **held at Neshaminy High School**.



Cost: **\$250.00** per person (\$240.00 for second child from the same family). Information and registration forms can be found on the district website at www.neshaminy.org.

Summer Fine Arts – Instrumental Music (Grades 3 - 12)



Program held from July 3, 2017 – August 1, 2017 and **will be held at Neshaminy High School**. Cost is **\$130.00** per student (\$120.00 for second child from the same family). Summer S.T.E.M. Academy and CSI: Neshaminy (Grades 4 - 8)

Students in grades 4 - 8 will have the opportunity to work closely with teachers and engineers to learn an integrated approach to the study of science, technology, engineering and math. They will use the LEGO NXT brick building set to construct models and to find robotic solutions to real world problems. Cost is \$130.00 for beginners (July 10 - 14 and July 17 - 21) and intermediate (July 24 - 28) and \$165.00 for advanced (July 31 - August 4).





CSI: Neshaminy--Crime solvers in grades 5 and 6 will engage in hands on exploration of the world of forensic science. Participants will examine toxicology reports, fiber analysis, hair samples, bite marks and fingerprints in order to solve a mystery that is based on a puzzling classroom crime when a teacher is shocked to find her well-loved cookie jar, used for reward, is smashed to pieces. Students will examine and analyze the evidence to figure out this "Who Dunnit." Cost is \$130.00 and runs from August 7 – 11.

Elementary Summer Tutoring Program



The purpose of the elementary tutorial program is to provide assistance to those children who need extra help in math and reading. Participation in the summer program will enable students to reinforce skills taught during the school year. It will also decrease the time gap between school years thereby helping children to retain information.

Students will attend at no cost. Pupils will be invited to participate based on an established set of criteria. There will be no "open" enrollment. Student enrollment is limited to 120 students (10 classes of 12 students).

English Language Learner Intensive Language Lab (K – 11th grades)

The English Language Learner Intensive Language Lab is a program designed to provide English language instruction for English as a Second Language students. (Thursday, July 6 to Thursday, August 3 at Maple Point Middle School 8:15 a.m. – 11:30 a.m. Monday - Thursday)

Students will attend at no cost.

<u>Location/Hours:</u> Neshaminy High School, 2001 Old Lincoln Highway, Langhorne, PA 19047. **Classes begin Monday, July 10, 2017 at 7:10 a.m., and end Friday, August 11, 2017. Students will receive schedules at on Monday, July 10, 2017.**

ELIGIBILITY: Persons of any age who have completed at least sixth grade.

REGISTRATION: Registration forms, along with tuition payment must be completed by Monday, June 26, 2017. The completed registration form including the fee should be submitted to: **Mr. Andre Modica, Summer School Principal, Neshaminy High School, 2001 Old Lincoln Highway, Langhorne, PA 19047.** Private and parochial school students may mail in the application. A counselor will be available at the high school for registration on Wednesday, June 21, Thursday, June 22 and Monday, June 26 from 7 a.m. – 3 p.m..

<u>Neshaminy Students</u>: To enroll for a make-up course, a student must have either an administrator or counselor approve their registration form.

<u>LATE REGISTRATIONS:</u> Registrations after June 26th must be made to Mr. Andre Modica, Summer School Principal, Neshaminy High School. **A \$10.00 late registration fee will be charged**. Late Registration hours are from 8:00 a.m. to 2:00 p.m. beginning Tuesday, June 27th. Late registration will be accepted no later than Friday, June 30, 2017.

COURSES COMBINED: A course with low enrollment may be combined with a similar course in order to provide a viable program.

<u>COURSES CANCELLED</u>: The summer school office reserves the right to close any course that is filled or to cancel any course for which there is insufficient enrollment.

REFUND POLICY: Registrations fees will be returned **ONLY** when students cannot be enrolled due to closed or cancelled courses. No other refunds will be made!

MAKE-UP Courses: All classes are 5 weeks. Students in make-up courses will need to meet all administrative requirements: Academic standards, attendance/lateness standards, and compliance with the code of conduct. Neshaminy students in make-up courses are expected to demonstrate their proficiency of the subject matter taught during the summer and meet the academic requirements for a passing grade—75%. Grading will be based on Pass/Fail.

ENRICHMENT Courses: Students enrolling in any course for enrichment only must meet minimum levels of competency. **Grading will be based on Pass/Fail on the competency only.**

CREDIT/GRADES: Students earning a passing grade will receive the appropriate credit for the failed/enrichment course.

ATTENDANCE/LATENESS: In order to receive credit, a student may not miss more than 3 days from the date of registration, for any reason, including suspension. Students are to be in their classrooms at the bell; (7:10 a.m. or 9:45 a.m.). Excessive lateness will convert to absences.

TRANSPORTATION: Summer School students must provide their own transportation. No school district buses will be provided.

PARKING: Limited parking spaces are available for student drivers. Students with unscheduled time between classes are expected to wait in designated areas. Students are not permitted to return to their cars or the parking lot, unless they are leaving school grounds for the day. A vehicle registration form can be found below, if you would like to apply to park.

You will be contacted by July 7th only if your class has been filled OR you have been scheduled for the 2nd session which begins at 9:45 a.m. on July 10th. Otherwise, the student should arrive at 7 a.m. on Monday, July 10, 2017 at Neshaminy High School to receive their room assignment.

3155 ENRCH - GEOMETRY (9th&10th only) (5 Hours)

Academic Geometry is intended for those students who have successfully completed Algebra I or Algebra I Part II with a final grade of B or better and teacher recommendation. This course will foster an understanding of the special properties of two and three-dimensional figures and emphasizes the relationships among points, lines, angles, triangles, polygons, and circles. An emphasis will be placed on the deductive proof. Neshaminy students who pass the district final exam for Accelerated Geometry with an 80% or higher will be awarded one math credit and will be permitted to schedule Algebra II during the next school year.

Pre-requisites: B in Algebra I or Algebra I Part II and teacher recommendation.

3055 ENRCH - ALGEBRA I PART II (5 Hours)

This course is offered to students who have successfully completed Algebra I Part I by earning a final grade of an A- or better and teacher recommendation. Topics will include utilizing algebraic operations, solving linear equations and inequalities, graphing equations, and solving quadratic equations. This course is a continuation of the study of the real number system. Neshaminy students who pass the district final exam for Algebra I Part II with an 80% or higher will be permitted to schedule Accelerated Geometry the next school year in 9th grade.

Pre-requisites: A- in Algebra I Part I and teacher recommendation.

3025 ENRCH - ALGEBRA II (5 Hours)

Academic Algebra II is intended for those students who have successfully completed Algebra I and Geometry with a final grade of B or better in each course and teacher recommendation. The course will move through a sequential study of inequalities, linear and quadratic functions, polynomials, higher degree equations, exponents, complex numbers, conic sections, and coordinate geometry. Neshaminy students who pass the district final exam for Honors Algebra 2 with an 80% or higher will be awarded one math credit and will be permitted to schedule Pre-Calculus during the next school year.

Pre-requisites: B in Algebra I and Geometry and teacher recommendation.



M-270 MATH 6TH- 8TH GRADE (2 hrs. 30 min.)

This course is offered for those students that did not successfully complete the 6th, 7th or 8th grade mathematics program. Topics will include whole numbers, decimals, fractions, number theory, proportions, measurement, and geometry along with other core math and/or pre-algebra concepts. Students will be required to take the district final exam for the course.

M-250 PRE-ALGEBRA (2 hrs. 30 min.)

This course is offered to those students in middle school who did not successfully complete Pre-Algebra. Topics will include integers and exponents, analyzing data, perimeter, area, volume, ratios and similarity, probability, percents, and solving equations and inequalities. Students will be required to take the district final exam for Pre-Algebra.

3000 ALGEBRA I, 3005 ALGEBRA 1 PART 2 (2 hrs. 30 min.)

This course is offered to students who did not pass Algebra I or Algebra I Part II and desire to receive credit. The course will cover the basic concepts and principles of Algebra, which includes utilizing algebraic operations, solving liner equations and inequalities, graphing equations, and solving quadratic equations.

3020 ALGEBRA II (2 hrs. 30 min.)

This course is offered to students who did not pass Algebra II and desire to receive credit. Topics will include quadratic functions, systems of equations, variations, irrational expressions, complex numbers, functions, and coordinate geometry.

3155 GEOMETRY (2 hrs. 30 min.)

This course is offered to those students who did not pass Geometry or Accelerated Geometry and desire to receive credit. This course will target topics including inductive reasoning, distance and angle measurement, angle and triangle relationships, triangles and congruence, parallel lines, and circles to name a few. Less emphasis is placed on geometric proofs.

L-210 ENGLISH 6TH- 8TH (2hrs. 30 min.)

This course is offered to students in middle school who have not successfully completed English and wish to receive credit. The curriculum will address features of writing such as vocabulary, sentence structure, and usage through student writing. Students will begin by writing paragraphs, progressing to the multi-paragraph essay, and will read nonfiction and a variety of short stories in a review of the elements of fiction (characterization, plot, setting, point of view, and theme).

1920 - 9TH Grade, 1020 - 10th Grade, 1120 - 11th Grade, 1220 - 12th Grade ENGLISH 9-12 (2 hrs. 30 min.)

This course is offered to students in high school who have not successfully completed English and wish to receive credit. Building upon skills taught in middle school, students will develop as readers and writers using grade-appropriate texts. All multi-paragraph essays will follow the guidelines of the PA Writing Rubric. Students will read short fiction, focusing on literary elements, as well as nonfiction with an emphasis on current events.

4900 INTEGRATED SCIENCE (2 hrs. 30 min.)

This course is offered to those students who failed 9th grade physical science. Topics studied will be related to the big ideas in Introductory Physics (forces, conservation of energy) and Chemistry (properties of atoms, chemical bonding, and transformation of energy) as they are defined in the state and national science standards.

4000 BIOLOGY (2hrs. 30 min)

This course is offered for those students who failed Biology. Topics included in this course are related the big ideas in Biology including cell structure and function, cellular movement, photosynthesis, cell division, ecology and classification as they are defined in the state and national science standards.

4040 CHEMISTRY (2hrs. 30 min.)

This course is offered to those students who failed Chemistry I. Topics for this course will be related to the big ideas in chemical sciences (properties of matter, atomic theory, chemical bonding, periodic trends, and chemical reactions.) as they are defined in the state and national standards.

4060 SCIENCE 12 - EARTH and SPACE SCIENCE (2 hrs. 30 min.)

This course centers on a study of the physical characteristics of the earth. It considers the forces that continuously change the earth's physical make-up and, through astronomy, develops an understanding of the universe and where the earth fits. Topics studied include meteorology, climatology, geology, oceanography, cosmology and astronomy.

2920 SOCIAL STUDIES 9- US WORLD HISTORY (2 hrs. 30 min.)

"American History: The Civil War - World War II"

This course is designed to strengthen student understanding of the evolution of the five American ideals (equality, liberty, rights, opportunity and democracy) promised in the Declaration of Independence. Students will develop skills of historical analysis such as identifying bias and understanding cause and effect relationships while studying key developments in American society from the Civil War to World War II.

2320 SOCIAL STUDIES 10- MODERN WORLD HISTORY (2 hrs. 30 min.)

"World History - The Renaissance - World War II"

This course is designed to explore historic developments in World history. The skills of historical analysis will be developed while students analyze the political, economic and religious systems within a historical framework. Major World events from the Renaissance through World War II will be the focus of study.

2220 SOCIAL STUDIES 11 - CONTEMPORARY US & WORLD HISTORY (2 hrs. 30 min.)

"Modern vs World History"

This course is designed to strengthen students' understanding of the modern history of the United States and the world. Students will examine key events from this period to develop the skills of historical analysis such as identifying bias and understanding cause and effect relationships.

2090 SOCIAL STUDIES 12 - PSYCHOLOGY/CIVICS and ECONOMICS (2hrs. 30 min.)

This part of the course is a basic introduction to psychology. Emphasis is placed on interpersonal relationships, self-understanding, personality formation and child development. Some specific areas of study include perception, the scientific methods, theoretical frameworks, learning, the maturation process, and self-evaluation.

Students will acquire the skills and knowledge necessary to become responsible and effective citizens in the United States. Students will gain a practical understanding of economics and how it affects their lives as consumers in an interdependent world. When studying the political and economic systems, students will become aware of their rights and responsibilities and put this information into practice. As informed decision-makers, students will apply acquired knowledge to real life experiences.

Neshaminy Summer School Behavior Code - 2017

-INTRODUCTION-

For the purposes of Summer School, this document serves as an overview of expected student behaviors and our disciplinary code. The guidelines notated in this document reflect the current Neshaminy High School Discipline Code. A copy of the Neshaminy High School Student Handbook will be available for perusal by students and parents, if needed. School Board Policy #505 authorizes the guidelines for administering discipline. Attendance expectations and other sections of the Neshaminy High School student handbook may not apply to Summer School. District Policy shall prevail should any part of the discipline code fail to address a situation.

-ATTENDANCE EXPECTATIONS-

Students are limited to <u>3 days</u> of accumulated absence from each class. <u>Lates</u> to class are cumulative. Students who exceed attendance limitations <u>WILL</u> be dismissed from the program WITHOUT REFUND. <u>Extenuating circumstances</u> will be looked at on a case by case instance. The principal will make all final decisions regarding attendance violations.

-TARDINESS

Students are expected to be in their classes at the scheduled start time. Entering the building at the scheduled start time does not make you on time for class. Tardies accumulate and convert to absences consistent with the following guidelines:

Type B	20 – 60 minutes	1 st time = .5 absence

Type C	60 – 75 minutes	1st time = .75 absence
		2 nd time = .75 absence
		Each subsequent tardy will count as a full 1.0 absence
Type D	75 minutes	Each occurrence will count as a full 1.0 absence

-DISCIPLINE-

Examples of student offenses requiring disciplinary action (This list is NOT all-inclusive):

- General misconduct
- Disruptive behavior
- Chronic lateness to school/class
- Use of foul /obscene language
- Insubordination
- Not signing into school
- Driving/parking violations
- Failure to return school forms
- Failure to abide by the student dress code. Hats, hoods, bandanas, etc. must be removed upon entering the school. Inappropriate attire (e.g. dirty or torn, inappropriate language/design, overexposes body) Conservative attire is strongly suggested.

- Use of unapproved electronic devices during school hours. Upon entering classroom, cell phones are to be turned off and put away. Teachers may allow cell phone use if they are to be used for educational purposes. The teacher will make that determination. Failure to comply with this rule will result in confiscation. The first time, the phone will be returned after class has ended. A second offense will have the same outcome along with a parent contact made. Subsequent violations will necessitate a parent need to pick up the phone.
- Students may not preorder and have food delivered to the summer school.

In most cases, 1-3 days OUT-OF-SCHOOL SUSPENSION may result. Each day of suspension counts as day of absence.

SMOKING IS PROHIBITED IN THE SUMMER SCHOOL FACILITY AND ON THE CAMPUS.

Smoking and/or Possession of Tobacco Products will result in a 3 day Out-of-School Suspension as well as a Municipal Citation (approximately \$100.00)

Students found to be in an unauthorized area or in a suspicious situation are subject to search under reasonable suspicion. Student automobiles parked in our lot may be searched. Students who refuse a search will be dismissed from summer school WITHOUT REFUND.
