2) Approval of Employment of Dentist

Mr. Shubin read the following motion:

**WHEREAS**, PA Code, Title 28 Health and Safety, Chapter 23 § 23.1 Required Health Services states that school districts shall provide dental examinations to school age children, and...

**WHEREAS**, § 23.3 (a) states Dental examinations shall be required on original entry into school and in grades three and seven, and

**WHEREAS**, § 23.8 states that school districts shall maintain comprehensive dental records of each student, be it resolved that Neshaminy School District will enter a contractual agreement with Dr. Raven D.D.S. retaining his services to provide dental examinations at a cost of \$7.00 per student.

Mrs. Cummings seconded the motion.

The Board unanimously approved said motion by a vote of 9 ayes and 0 nays.

3) Contracted Transportation Services for 2015 - 2016

Mr. Allen read the following motion:

**WHEREAS**, the school district transports public, private and parochial school students in accordance with the applicable state laws; and

**WHEREAS**, private contractors are sometimes used if it is more practical and less expensive to do so with other than district staff and vehicles.

**NOW, THEREFORE, BE IT RESOLVED**, that the Neshaminy Board of School Directors authorizes the administration to enter into a private contract for the 2015-2016 school year for the transportation of certain students in accordance with state regulations as follows:

4) Approval of New Board Policy #527

Ms. Boyle read the following motion:

**WHEREAS**, in order to keep District Board Policies updated and current, new policies are recommended by the administration to the Board Policies Committee for review, and

**WHEREAS**, recommended policies meet the requirements of Federal Law; and

**WHEREAS**, after review by the Board Policies Committee, the District is ready to recommend:

New Policy 527 – Suicidal Awareness and Prevention

**NOW THEREFORE BE IT RESOLVED**, that the Neshaminy Board of School Directors approve the new Policy as recommended by the School Board Policies Committee.

Mrs. Cummings seconded the motion.

The Board unanimously approved said motion by a vote of 9 ayes and 0 nays.

- 5) Approval of Confidential Agreement  
Mrs. Cummings read the following motion:

**WHEREAS**, the Neshaminy School District has entered a private and confidential agreement with the family of DM, be it resolved that Neshaminy School District will fund an educational program at A Step Up Academy through the 2018 - 2019 school year.

Mr. Shubin seconded the motion.

The Board unanimously approved said motion by a vote of 9 ayes and 0 nays.

- 6) Public Hearing for the Closure of Oliver Heckman Elementary School  
Mr. Torrente read the following motion:

**RESOLUTION**

Resolution of the Board of School Directors of the Neshaminy School District to hold a Public Hearing of the Board to consider the permanent closure of Oliver Heckman Elementary School.

The Board of Directors of the Neshaminy School District do, pursuant to Article VII, Section 780 of the Pennsylvania Public School Code of 1949, as amended, resolve that a Public Hearing of the Board will be held in the Auditorium of Maple Point Middle School, 2250 Langhorne-Yardley Road, Langhorne, PA 19047 on Wednesday, January 6, 2016 at 7:00 p.m. upon the question of whether or not to permanently close the Oliver Heckman Elementary School located at Maple Avenue and Cherry Street, Middletown Township, Bucks County, PA at the end of the 2015 - 2016 School Year.

The Administration of the School District and the Solicitor are hereby authorized and directed to advertise the Public Hearing and to take all action required by law to be taken in conjunction with the holding of the Public Hearing. The public will be invited to attend and participate in the hearing as permitted by law.

Mr. Sposato seconded the motion.

Mr. Congdon called for a roll call tally and the tally indicated that the motion passed by a vote of 7 ayes, (Mr. Allen, Ms. Boyle, Mr. Congdon, Mrs. Cummings, Mr. Pirritano, Mr. Shubin, and Mr. Sposato), 1 nay, (Mr. Rudy), and 1 abstention, (Mr. Morris).

- 7) Public Hearing for the Closure of Lower Southampton Elementary School

accomplished this all while embarking on an infrastructure plan to revitalize our district facilities. A total of \$63 million over three years with no yearly tax impact to our residents; by applying these business like practices; prudent conservative financial management, proper professional consultants, leveraging our excellent Bond rating to achieve the markets historically low interest rates while managing our reserves properly. None of this would be possible without employing excellent administrators at our cabinet level that are not only respected educators but proven managers of what amounts to be a \$174 million Non-Profit Entity. I am also very concerned about the proposed fair funding formula that may be adopted. Currently, as written, I foresee districts like Neshaminy losing State funds, not gaining; applying more pressure upon us to hold the line on taxes. The State should never be placing our schools in a position where we have to cut programs and staff to meet under funded mandates. We have done the hard work and let me remind you members like I, volunteer our time, we do not want or expect compensation. What we do expect, is a State government that works to bolster us, not handcuff us.

If you want School Boards to limit taxes what we need is real reform; pension reform, collective bargaining reform, and unfunded mandate reforms. Senate Bill 909 is a large brush approach to very complicated issues. It is knee jerk reactionary to a problem long kicked down the road by various administrations and legislatures. Please vote NO on Senate Bill 909 and offer us the relief to manage properly instead.
