BOARD REORGANIZATION MEETING

Call to Order

Mrs. Burns called the meeting to order at 7:01 p.m.

Roll Call

A roll call indicated that a quorum of directors was present and the meeting was duly convened.

Mrs. Burns requested those in attendance join in the salute to the flag.

Reorganization of the Board of School Directors

a) <u>Nomination of Temporary President</u>

Mrs. Burns opened the floor for nominations for Temporary President for the reorganization of the Neshaminy Board of School Directors. Mr. Congdon nominated Ms. Boyle. Mr. Sanna nominated Mr. Morris. Mr. Morris respectfully declined. There were no other nominations. Mr. Congdon moved that nominations for Temporary President of the Neshaminy Board of School Directors be closed and Mr. Pirritano seconded the motion.

A roll call tally indicated that Ms. Boyle was elected Temporary President of the Neshaminy Board of School Directors by a vote of 9 ayes, and 0 nays.

b) <u>Election of President</u>

Ms. Boyle opened the floor for nominations for President of the Neshaminy Board of School Directors. Mr. Sullivan nominated Mr. Congdon. Mr. Morris nominated Mr. Rudy. Ms. Boyle moved that nominations for President of the Neshaminy Board of School Directors be closed. Mr. Congdon seconded the motion. The Board unanimously moved that nominations for President of the Neshaminy Board of School Directors be closed.

Ms. Boyle requested a roll call. The roll call tally indicated that Mr. Congdon was elected President of the Neshaminy Board of School Directors for 2017, by a tally of 5 votes for Mr. Congdon, (Ms. Boyle, Mr. Congdon, Mrs. Hollenbach, Mr. Pirritano, and Mr. Sullivan) and 4 votes for Mr. Rudy (Mr. Feather, Mr. Morris, Mr. Rudy, and Mr. Sanna.)

c) Election of Vice-President

Mr. Congdon opened the floor for nominations for Vice-President of the Neshaminy Board of School Directors. Mr. Congdon nominated Ms. Boyle and Mr. Rudy nominated Mr. Morris. Mr. Congdon moved that nominations for Vice-President of the Neshaminy Board of School Directors be closed. The Board unanimously moved that nominations for President of the Neshaminy Board of School Directors be closed.

Mr. Congdon requested a roll call. The roll call tally indicated that Ms. Boyle was elected Vice-President of the Neshaminy Board of School Directors for 2017, by a tally of 5 votes for Ms. Boyle, (Ms. Boyle, Mr. Congdon, Mrs. Hollenbach, Mr. Pirritano, and Mr. Sullivan.) and 4 votes for Mr. Morris (Mr. Feather, Mr. Morris, Mr. Rudy, and Mr. Sanna.)

Public Comment

Anthony Sposato, business owner, resident of Middletown Township, voiced his support for the MaST Charter School. Mr. Sposato stated that although it will be an initial financial burden on the district in the long term money will be saved by lowering salary costs, vacation, sabbatical costs, and pension obligations. Mr. Sposato said if MaST is welcomed into Neshaminy it will raise the standard of education for students and the long term benefit to the community far out way the short term effects.

Steve Rodos, retired, resident of Villages of Flowers Mills, thanked Don Harm for his invaluable service to the community. Mr. Rodos expressed his dissatisfaction with the food service in the high school in relationship with staff treatment. He stated that the service provided to staff members is almost non-existent. Mr. Rodos mentioned that the heating and air conditioning in the high school needs to be refurbished. He concluded by saying that he is disappointed that some members of the Board are still part of a group that are consistently opposed to any attempt by the district to improve matters.

Deb Harker, resident of Middletown Township, expressed support for the MaST Charter School in Neshaminy. She stated that the Charter Appeal Board in Harrisburg voted unanimously in favor of the charter school recognizing that MaST offers a unique educational opportunity. She is disappointed that the district continues to appeal the charter school's application. Ms. Harker asked the Board to stop wasting taxpayers' money and allow MaST Charter School to begin instruction in the fall.

1. Motion: Appointment of Solicitor

Mr. Congdon presented the following motion:

WHEREAS, The School Board Policy #100 requires during the month of December that the Board of

School Directors appoint a solicitor for a one year term;

NOW, THEREFORE, BE IT RESOLVED, that the Board of School directors reappoint the law firm of Begley, Carlin & Mandio as Solicitor of the Neshaminy School District in accordance with its fee letter.

Mr. Feather seconded the motion.

The Board unanimously approved said motion by a vote of 9 ayes and 0 nays.

Mr. Profy thanked the Board for the vote of confidence, on behalf of Begley, Carlin & Mandio, and said that they look forward to serving the Neshaminy School District for the upcoming school year.

2. <u>Motion: Approval of Meeting Schedule</u>

Mr. Congdon read the following motion:

WHEREAS, the Board of School Directors must adopt and publish a schedule of Public Meetings for 2017;

NOW, THEREFORE, BE IT RESOLVED, that the 2017 School Board Meeting Calendar be adopted by the Neshaminy Board of School Directors.

Mr. Sullivan seconded the motion.

The Board unanimously approved said motion by a vote of 9 ayes and 0 nays.

3. <u>Motion: Approval of Policy Revisions</u>

Mr. Congdon read the following motion:

WHEREAS, in order to keep district board policies updated and current, revisions of select polices are recommended by the administration to the Policy Committee for review; and

WHEREAS, recommended policies meet the requirements of Federal Law; and

WHEREAS, after review by the Policy Committee, the District is ready to recommend:

- Revised Policy #501 School Entrance Age, and
- Revised Policy #512 High School Diploma;

NOW, THEREFORE BE IT RESOLVED, that the Neshaminy Board of School Directors hereby approves the revised policies #501 and #512.

Ms. Boyle seconded the motion.

The Board unanimously approved said motion by a vote of 9 ayes and 0 nays.

4. <u>Motion: Overnight Trips</u>

Mr. Congdon read the following motion:

WHEREAS, according to Board Policy #618, trips extending overnight are permitted by authorization of the Neshaminy Board of School Directors only;

NOW, THEREFORE, BE IT RESOLVED, that the Neshaminy Board of School Directors hereby approves the following overnight trips:

- Neshaminy High School Wrestling Team to the Wrestling tournament, December 20 30, 2016 Governor Mifflin High School, Shillington, PA
- Neshaminy High School Boys and Girls Track Team to the State Indoor Track Championship, February 24 25, 2017 University Park, PA.

Mr. Hollenbach seconded the motion.

The Board unanimously approved said motion by a vote of 9 ayes and 0 nays.

5. Motion: Petition to Allow for Appeal of the MaST Charter School Decision

Mr. Congdon read the following motion:

WHEREAS, MaST-Neshaminy did, on October 18, 2012, submit an Application with the School Board to establish a charter school within the District that would focus on providing science, technology, engineering and mathematics to students in grades kindergarten through 12; and

WHEREAS, the Board of School Directors held public hearings on November 29, 2012, and February 11, 2013, on the charter school application of MaST-Neshaminy; and

WHEREAS, the Board of School Directors did, on March 18, 2013, adopt a Resolution with Findings of Fact and Conclusions of Law in support of its denial based upon three reasons:

- (1) Lack of demonstrated sustainable support for the charter school;
- (2) Failure to identify a suitable facility; and
- (3) Failure to demonstrate that MaST-Neshaminy would be a model for other public schools; and

WHEREAS, MaST-Neshaminy filed an Appeal with the Charter Appeal Board (CAB) which did, on January 6, 2016, grant MaST-Neshaminy's Appeal and directed the District to issue MaST-Neshaminy a charter; and

WHEREAS, the School District did, on January 14, 2016, file a Petition for Review of the action of CAB to the Commonwealth Court of Pennsylvania, and said Court did, on November 10, 2016, enter an Order affirming January 6, 2016, Order of CAB directing the School District to issue MaST-Neshaminy a charter; and

WHEREAS, the School District desires to petition the Supreme Court of Pennsylvania for an allowance for appeal of the November 10, 2016, Order of the Commonwealth Court of Pennsylvania;

NOW, THEREFORE, BE IT RESOLVED, that the Board of School Directors of the Neshaminy School District approve and authorize the filing of a Petition for Allowance of Appeal to the Supreme Court of Pennsylvania from the November 10, 2016, Order of the Commonwealth Court of Pennsylvania; and

IT IS FURTHER RESOLVED, that the Officers and Solicitor of the School District are hereby authorized and directed to execute such other documents and to perform such other acts as said Officers and Solicitor that, in their discretion, are deemed necessary and desirable to effectuate the intent of this Resolution.

Mr. Pirritano seconded the motion.

Mr. Morris commented that he supports the Charter School application because he believes in giving parents and students more choices in education.

Mr. Congdon called for a roll call vote and the tally indicated that the motion passed by a vote of 7 ayes, (Ms. Boyle, Mr. Congdon, Mrs. Hollenbach, Mr. Pirritano, Mr. Rudy, Mr. Sanna, and Mr. Sullivan) and 2 nays, (Mr. Feather and Mr. Morris).
