Call to Order

Mr. Congdon called the meeting to order at 7:08 p.m.

Pledge of Allegiance

Mr. Congdon requested those in attendance join in the salute to the flag.

Announcements

Mr. Congdon read the following statement:

As many are aware, a complaint was filed with the Pennsylvania Department of Economic and Community Development, better known as the DECD, recently from a group of residents about the district's bond issue. One of the purposes of the DECD, is to review and approve the process of bond issuance. This action complaint took no one by surprise. It is a ploy that has been used in the past as an attempt to derail projects. So we expect to see it appear again. For this reason we hired a top notch bond attorney, to ensure total compliance. What is startling about this complaint is the complete absence of any error, omission, or fault with our submission. I am not going to get into specifics because our solicitor, bond counsel, and lawyer, who will be litigating the case, have advised us not to speak on this issue. Let me just say that we expect to prevail and we truly hope that this gambit will not cost the district time and money. The bond interest rates are at all-time lows and we have important construction to begin. If we cannot accomplish the full scope of the project, that would be a shame for the students, parents, and tax payers of this district.

Superintendent's Report

Mr. Copeland advised the Board on the following:

- Hoover was named Title I Distinguished School, wins grant.
- · Voting on the revised school calendar.

Public Comment

Robert Sanna, Middletown, asked the Board what plans have been made regarding the Everitt building. He also asked if Heckman were to stay open, what would be the third elementary school to be closed. Mr. Sanna reiterated that he is against any school closings and the 5th grade moving up to the middle schools.

Karen Lowry, Lower South, stated that the reason people bought homes in the gate sections was because of the Samuel Everitt Elementary School. She expressed her displeasure with the Board's decision to follow through with the closing of Everitt, despite the outpouring of the community's pleading with the Board to keep Everitt open.

Kevin Gallagher, IT analysis, Middletown, stated that the filing of the complaint against the district by a small group of people to pause the bond issuance, will only negatively affect all of the students and staff targeted for upgrades and improvements. Mr. Gallagher stated that consolidation has been talked about for a decade in the district and it's time for upgrades such as security, HVAC improvements, windows, and air quality enhancements. He also said that this anti-consolidation group is aware that by stopping this action could result in higher taxes.

Staci O'Brien, Middletown, asked the Board when the modulars were added to Heckman and what duration of time they are expected to be utilized for.

Robert Tull, consultant and former Board member, Levittown, stated he is against the consolidation and the closure of the schools because he believes the district has forgotten what the neighborhood schools are for. He said that the people who have purposely bought homes there will be denied walking their children to school. Mr. Tull said that the reason that the complaint was filed is because the Board has ignored the community. He also said that the Board's intentions are misguided because they are trying to solve a middle school problem by closing elementary schools.

Tim Sauritch, 5th grade teacher at Samuel Everitt, Fairless Hills, asked the Board to put a hold on the consolidation plan until after elections and if a new Board is elected, let the new Board make the decision whether to follow through with the consolidation plan.

Dara DeMari, Levittown, voiced her displeasure with the Board's decision to follow through with the consolidation plan and looks forward to voting in a new Board.

Howard Lindner, retired, resident, stated that he has many years of experience with School Boards and decision making and he feels this Board is making a big mistake. He said he firmly believes that the elections with bring forth a new School Board due to all the controversy.

Larry Pastor, business executive, Neshaminy, asked the Board to table the approval of insurance provider until more transparency can be provided to the public. Mr. Pastor voiced his support for the consolidation plan, stating that if Neshaminy doesn't do the right thing now, the district will be facing a much more serious financial disaster in the future.

Mr. Congdon made a motion to approve said Board minutes of February 17, 2015, and Ms. Boyle seconded the motion. The Board unanimously approved the February 17, 2015, Board minutes.

The Board unanimously approved said motion by a vote of 9 ayes, and 0 nays.

BE IT FURTHER RESOLVED, that students residing in Neshaminy School District be given first preference for program involvement and related program activities.

Motion: Reimbursement Resolution

WHEREAS, a motion to adopt a Reimbursement Resolution setting forth the intention of this School District to reimburse itself from the proceeds of tax exempt obligations for expenditures made by the School District to finance the costs and expenses of the planning, constructing and installing of certain energy-saving equipment, devices and projects in various School District buildings.

Motion: Approval of Revised 2014 - 2015 School Calendar

WHEREAS, due to inclement weather on January 27, February 17, March 5 and March 6, 2015 which closed schools for our K-12 student body, and

WHEREAS, in accordance with the Pennsylvania School Code, it is necessary to revise the calendar in order to meet the minimum state child accounting and attendance regulations;

NOW, THEREFORE, BE IT RESOLVED that the Board of School Directors approves the attached revised school calendar.

Mr. Congdon made a motion to pass items 1 through 6.

Mrs. Cummings seconded the motion.

Mr. Morris made a motion to separate item #3, Approval of PlanCon Part F Submission to PDE.

Mr. Rudy seconded the motion.

Mr. Congdon called for a roll call tally and the tally indicated that the motion failed by a vote of 2 ayes, (Mr. Morris and Mr. Rudy), and 7 nays, (Mr. Allen, Ms, Boyle, Mr. Congdon, Mrs. Cummings, Mr. Pirritano, Mr. Shubin, and Mr. Sposato.)

Mr. Congdon called for a roll call tally on items 1 through 6 and the tally indicated that the motion passed by a vote of 7 ayes, (Mr. Allen, Ms. Boyle, Mr. Congdon, Mrs. Cummings, Mr. Pirritano, Mr. Shubin, and Mr. Sposato) and 2 nays, (Mr. Morris and Mr. Rudy.)

Motion: Approval of Insurance Provider

Mr. Shubin read the following motion:

WHEREAS, approval of Assurant provided through Innovative Risk Solutions, Inc. as the provider of the Neshaminy School District Employer provided Life, Accidental Death and Disability, Short-Term Disability and Long-Term Disability Insurance coverages as well as voluntary life, short-term disability and long-term disability insurance coverage. Coverage will begin as soon as transition can be completed; and

NOW, THEREFORE BE IT RESOLVED, that the Neshaminy Board of School Directors approves Assurant as the life insurance provider.

Mr. Sposato seconded the motion.

Mr. Morris made a motion to table item #7, Approval of Insurance Provider, because of discrepancies within the information and until further transparency is achieved.

Mr. Rudy seconded the motion.

Mr. Congdon called for a roll call tally and the tally indicated that the motion failed by a vote of 4 ayes, (Ms. Boyle, Mr. Morris, Mr. Rudy and Mr. Shubin) and 5 nays, (Mr. Allen, Mr. Congdon, Mrs. Cummings, Mr. Pirritano, and Mr. Sposato.)

Mr. Congdon called for a roll call tally on item #7 and the tally indicated that the motion passed by a vote of 5 ayes, (Mr. Allen, Mr. Congdon, Mrs. Cummings, Mr. Pirritano, and Mr. Sposato) and 4 nays, (Ms. Boyle, Mr. Morris, Mr. Rudy, and Mr. Shubin.)

Motion: Permanent Closure of Everitt Elementary School

Mr. Sposato read the following motion:

WHEREAS, in accordance with the Resolution adopted on November 18, 2014, the process for the permanent closure of Samuel Everitt Elementary School ("School"), pursuant to the Pennsylvania Public School Code of 1949, as amended, was initiated; and

WHEREAS, a Public Hearing was held at Maple Point Middle School Auditorium, 2250 Langhorne-Yardley Road, Langhorne, Pennsylvania on December 15, 2014 at 7:00 p.m. upon the question of whether or not to permanently close the Samuel Everitt Elementary School located at Forsythia Drive South, Levittown, Middletown Township, Bucks County, Pennsylvania at the end of the 2014-2015 School Year; and

WHEREAS, this action is being taken because of the declining student enrollment at the elementary school level throughout the School District, and the School is situate in an area of student population decline; and

WHEREAS, the School, which has a PDE capacity: Regular 525 and Maximum Practical Capacity 521 has an enrollment of only 395 students in grades K-5, which is the second smallest enrollment of an elementary school in the School District; and

WHEREAS, the School, constructed in 1954, and last expanded and renovated in 1968, requires the most extensive and costly renovations of any other elementary school in the School District; and

WHEREAS, the proximity of the School to other elementary schools minimizes the impact of the closure of the School on the reassignment and transportation of students of the School; and

WHEREAS, the School District will realize substantial operating and maintenance costs savings upon the closure of the School.

NOW, THEREFORE, BE IT RESOLVED, that the Neshaminy Board of School Directors hereby officially declares that Samuel Everitt Elementary School will permanently close at the end of the 2014-2015 School Year.

Mr. Pirritano seconded the motion.

Mr. Congdon called for a roll call tally and the tally indicated that the motion passed by a vote of 7 ayes, (Mr. Allen, Ms. Boyle, Mr. Congdon, Mrs. Cummings, Mr. Pirritano, Mr. Shubin, and Mr. Sposato) and 2 nays, (Mr. Morris and Mr. Rudy.)

Other Board Business

Mr. Congdon stated that a new committee will be formed to look at the rest of the buildings in the district.

Public Comment

Stacie O'Brien, Middletown, advised the Board not to focus solely on the bottom line figures of an insurance company, but rather on the type of service that they provide.

Larry Pastor, business executive, Middletown, concluded his comments by saying the decision on consolidation must be made with the consideration of all the children in the district not one particular area. Mr. Pastor urged Mr. Congdon and the Board to review the issue of the health insurance provider. Mr. Pastor asked the Board counsel and Board President to investigate the matter of two Board members who are associated with a group that is bringing legal action against the district because of the consolidation plan.

Howard Lindner, retired, voiced his support for the Board members who are against the consolidation plan and stated that everyone has the right to their own opinion and to stand up for what they believe in.

Jennifer Willeter, Levittown, asked the Board to reconsider the up-to-date information on the student enrollment because the consolidation plan was formed with outdated data and misinformation.

Beth Ann Pollack, Levittown, voiced her concern over where the Samuel Everitt school children will go after the school is closed.

Robert Tull, Levittown, voiced his opposition to the consolidation project and asked them to consider what might happen if a new elected School Board reverses the decision.

Richard Geiger, Levittown, said he is against consolidation because it eliminates neighborhood schools. He also expressed concern over the future occupancy of the Samuel Everitt building.

Joyce Dworsky, Levittown, asked the Board if research was done as to the optimal number of students in an elementary school. She also asked what will happen to the Everitt property.

Paul Murdoch, Levittown, expressed doubts about the consolidation plan and the future of the Neshaminy School District.

Robert Sanna, Levittown, stated that there are a lot of misconceptions regarding the consolidation plan, and he again asked the Board to put it to a referendum.

Jennifer Simpson, Levittown, thanked Mr. Morris and Mr. Rudy for trying to save Samuel Everitt Elementary School. She expressed her disappointment at the vote to close Everitt and said she is against the fifth grade moving up to middle school. She asked the Board to explain why photographs were being taken inside the Samuel Everitt School during classes.

Timothy Sauritch, 5th grade teacher at Samuel Everitt, thanked those persons who came out to support Samuel Everitt and questioned why the decision simply can't be postponed until after the School Board elections.

Tony Locklear, Levittown, recalled his traumatic experience as a child being bused to another school outside of his area. Mr. Locklear said he hopes that Neshaminy students will never have to have such an experience in the future.

Rita Bakshi, Langhorne, stated that upcoming elections are not a good reason for putting the consolidation plan on hold.

Elizabeth Klebe, Levittown, stated that the Board should keep in mind that enrollment runs in cycles and eventually will change again in the future. Mrs. Klebe also expressed concern about the 5th through 8th grade model and the issues of busing young students to other schools.

Bob Feather, Levittown, asked what will happen to the schools once they are closed. Mr. Feather said there are too many unanswered questions that need to be answered such as busing and eliminating staff positions before moving forward with this plan.

Dara DeMari, Levittown, said the Board can expect that supporting the consolidation plan will result in defeat at the polls in the upcoming election.

Board Comment

Mr. Sposato emphatically stated that the consolidation decision has nothing to do with politics. He said education is a priority and that is the motivation of the Board. He said the children will not be bused across the district; they will go to the next school that is closest to their homes. Mr. Sposato said he stands behind the plan and is willing to take responsibility because he truly believes in it.

Mr. Copeland clarified that Mr. Minotti and an appraiser were at Samuel Everitt Elementary School to tour the building to gather information for negotiations with the IU.

Mr. Morris said any Board member, including himself, has the right to an opposing opinion and he has no trepidation about an investigation into his motives. He said that building a mega school does not benefit all the children in the district. He still supports renovating all the elementary schools, which would benefit all students.

Mr. Shubin stated that Samuel Everitt School should have been renovated years ago, but it was not and that is why the current situation exists. He said the new plan will deliver better education to the children in a smaller footprint.

Mr. Morris mentioned that the reason money was not spent to renovate Samuel Everitt several years ago is because the district was involved in intense contract negotiations with the certified and support staff and the district was in a financial crisis. Mr. Morris reiterated that fifth graders are not ready for middle school and he stands by that opinion.

Public Board Meeting Minutes of the Neshaminy Board of School Directors (cont.) March 17, 2015

Mr. Pirritano thanked the seven members of the support staff that recently retired for their dedication and service. He stated that any unanswered questions can be resolved at the Ad Hoc Committee meetings. Mr. Pirritano said the district will continue to handle any closed buildings in the same way that it has in the past. He assured the public that he has obtained information from local realtors that property values have not dropped in the areas where schools have been closed. He stated that it is the quality of the educational system that determines property values, not the number of buildings. He said the Board has no intention of selling the buildings. They will utilize them to bring revenue to the district.

Mr. Allen reiterated that children will not be bused to the other side of the district. He said all Neshaminy residents are invested in the education of the district's children. He said while they do not want to close schools, it does not mean it is the wrong decision.

Ms. Boyle said that the discussion of closing a school has been ongoing for many years. She asked the public to understand that this decision is for the benefit of the children and it would be irresponsible of the Board to ignore what is the right thing to do. Ms. Boyle said that it is the responsibility of Board members to do the right thing even if it is not the popular view.

Mr. Congdon said most actions by the Board take several years to transpire. He said there are good things ahead for Neshaminy and he looks forward to going forward.

Adjournment

Mr. Congdon moved the meeting be adjourned and Mr. Pirritano seconded the motion. The Board unanimously approved the motion. Mr. Condon adjourned the meeting at 9:27 p.m.
