NHS SKI CLUB 2018 Overnight Trip

A. The Overnight Ski Trip will be from Friday February 16 to Sunday February 18, 2018. We will leave the High School Friday at 3:30 and arrive back Sunday at 9:30 PM

The cost of the trip is \$375. This includes the 2 Day Lift Ticket, Transportation, 2 Breakfasts, 1 Dinner, 2 Nights lodging in Comfort Inn, Rutland.

Checks should be made out to "Neshaminy High School" - Due February 2, 2018

B. Alcohol and smoking of any kind is prohibited during any part of this trip. Students found breaking this rule will not be permitted to attend subsequent trips. Furthermore, penalties for this infraction will be dictated by the current rules in effect at Neshaminy High School. Anyone who does not follow rules set by the chaperones will not be eligible for future trips. Final approval for participation on this trip is contingent upon discipline code and history. Students involved in disciplinary actions in school may be denied a spot on this ski trip.

C. STUDENTS ARE RESPONSIBLE TO BRING AND SAFEKEEP THEIR EQUIPMENT
