Public Comment

Pam Jakubek, registered nurse, resident of Middletown Township, voiced her disapproval that the overseas trips were cancelled. She stated that there are counter-terrorism measures in place in Europe that are stronger than we have in the U.S.A. and she feels the students are being deprived of an educational experience of a lifetime.

Zoey Joyce, Neshaminy student, resident of Langhorne, said the cancellation of the overseas trips has caused a great deal of disappointment to some students and parents and the Board has disregarded their wishes. Zoey asked the Board to reconsider their decision.

2) School Director Recognition Month - January 2016

WHEREAS, these local boards have discharged their responsibilities to public education in a manner which has placed public education in the forefront of our educational systems; and

WHEREAS, locally elected officials have distinguished themselves and their communities in this nonpaid, volunteer public service commitment; and

WHERE, the contributions of these men and women should be recognized and appreciated by those who benefit the workings of our public school system.

NOW, THEREFORE, BE IT RESOLVED, that the Neshaminy Board of School Directors hereby proclaims the month of January as School Director Recognition Month.

Mrs. Hollenbach seconded the motion.

The Board unanimously approved said motion by a vote of 7 ayes and 0 nays. (Mr. Morris and Mr. Feather were not present.)

3) Approval of the 2016 - 2017 Proposed School Calendar

Mrs. Hollenbach read the following motion:

WHEREAS, each year the Board of School Directors must establish an official school calendar for the coming year; and

WHEREAS, the six participating school districts of the Bucks County Technical High School strive to establish a common school calendar; and

WHEREAS, the Board of School Directors reviewed the proposed calendar at the January 12, 2016 Public Work Session; and

WHEREAS, the proposed calendar was forwarded for comments to each of the employee bargaining groups.

NOW, THEREFORE, BE IT RESOLVED, that the Neshaminy Board of School Directors adopt the attached school calendar for the 2016 -17 school year.

BE IT FURTHER RESOLVED, that the Board of School Directors specifically designate Section 1502 holidays: December 23 and 27, 2016; February 20, 2017; and April 13 and 14, 2017 as five official local school district holidays.

Mr. Sullivan seconded the motion.

The Board unanimously approved said motion by a vote of 7 ayes and 0 nays. (Mr. Morris and Mr. Feather were not present.)

4) Deputy Tax Collector for Hulmeville Borough

Mr. Congdon stated that item #4, Deputy Tax Collector for Hulmeville Borough is tabled.

Mr. Profy recommended to the Board that they ratify and confirm the appeal of the Charter Appeal Board January 6, 2016 determination reversing the determination of the School Board rejecting the Charter to MaST Neshaminy and the granting of the Charter to MaST.

Mr. Congdon made a motion to approve the actions described by Mr. Profy.

Ms. Boyle seconded the motion.

The Board unanimously approved said motion by a vote of 7 ayes and 0 nays. (Mr. Morris and Mr. Feather were not present.)

5) Adoption of the 2016 - 2017 Preliminary Budget

Mr. Congdon read the following motion:

WHEREAS, in accordance with Act 1 of 2016, the Board of School Directors has received a Proposed preliminary Budget for the 2016 - 2017 fiscal year; and

WHEREAS, the Proposed Preliminary Budget was made available for public inspection on form PDE-2028 effective January 7, 2016; and

WHEREAS, in order to further comply with Act 1, the Preliminary Budget must be adopted by the Board of School Directors on or before January 27, 2016; and

WHEREAS, Act 1 further provides for "referendum exceptions", which must be submitted to and approved by the Pennsylvania Department of Education on or before February 11, 2016.

NOW, THEREFORE, BE IT RESOLVED, that the 2016 - 2017 Preliminary Budget is adopted in accordance with Act 1 of 2006 and t shall be made available for public inspection as required by law.

BE IT FURTHER RESOLVED, that the School District shall apply to the Pennsylvania Department of Education for exceptions specified under Act 1 as per the attached summary.

Mr. Pirritano seconded the motion.

The Board unanimously approved said motion by a vote of 7 ayes and 0 nays. (Mr. Morris and Mr. Feather were not present.)

Other Board Business

Mr. Profy recommended to the Board that motion be made authorizing the Board President and Secretary to execute and have the Board approve a three year extension of the employment contract of the Director of Business Operations.

Mr. Congdon made a motion to accept Mr. Profy's recommendation as stated.

Mrs. Hollenbach seconded the motion.

The Board unanimously approved said motion by a vote of 7 ayes and 0 nays. (Mr. Morris and Mr. Feather were not present.)

Public Comment

Grace Merian, Neshaminy student, said the Board is ignoring the opinions of the people they represent by cancelling the overseas trips.

Jeff Calabro, attorney, resident of Middletown Township, said the actions of the Board were deplorable by cancelling the overseas trips. He further stated the parents will be losing some deposit monies and the school district should be responsible for reimbursing the parents. He said if this is not done a lawsuit will be considered.

Angela Clark, resident of Langhorne Manor, implored the Board to keep Oliver Heckman Elementary School open. She mentioned the stress of increased childcare costs and long busing times that parents and children

will be subjected to.

Joanna McGee, resident of Langhorne Borough, said it is not reasonable to close Oliver Heckman because it is the only elementary school in the northern end of the district. Ms. McGee listed various advantages to keeping the neighborhood school open and urged the Board to respect the wishes of the Heckman community. Ms. McGee asked why the lease for the Mayor's Playground has not yet been signed.

Pam Jakubek, registered nurse, resident of Middletown Township, asked why the Board considers trips to Costa Rico or Washington, D.C. any safer than London, England.

Future Topics

None.

Board Comment

Mr. Pirritano commended that the snow removal crews did a great job in getting the building parking lots cleared efficiently. Mr. Pirritano confirmed with Mr. Profy that the contract has been signed for the lease of the Mayor's Playground. He also thanked the members of the public who came out for the meeting.

Mr. Congdon thanked the individuals for voicing their opinions about the overseas trips; however, the Board is accountable for the safety of the students and chaperones and they take that responsibility very seriously. He said when the Board was informed that a terrorist attack is highly likely, they must take it seriously and make the right decision, albeit an unpopular one. Mr. Congdon said the show deposit monies are not refundable, but the Board is looking into providing an alternative venue for the students.

Dr. Hancock apologized to the parents and students who are disappointed about the overseas trip. She said the Board has a very difficult task of taking on the responsibility for the safety of other people's children, so they must err on the side of caution. She said while it is true that the students may miss some level of learning experience by not going to Europe, this is an opportunity for parents to assist their children in coping with disappointment with maturity, understanding and grace.

Adjournment

Mr. Congdon moved the meeting be adjourned and Mr. Pirritano seconded the motion. The Board unanimously approved the motion. Mr. Congdon adjourned the meeting at 7:50 p.m.
