This addendum incorporates the minutes of the pre-bid meeting, February 25, 2020. These minutes and shall become part of the contract documents.

Pre-Bid Minutes

2. Any questions during bidding should be sent in writing to Joseph Rischow, jrischow@neshaminy.org.
3. It was noted that bids are due Thursday March 5th, 2020, 10:00 am at the purchasing office at **The Neshaminy High School**, located at 2001 Old Lincoln Highway, Langhorne, PA. Bids will be opened at 10:00 am and read at that time and place.
4. The project must be completed by July 31st, 2020. Liquidated damages will be assessed if not complete by July 31st, 2016 at \$400.00 per calendar day. This unit cannot be down for a long period of time and the schedule and down time must be coordinated with the district.
5. The basis of design is Innovent. The manufactures representative is Chase and Associates. The contact at Chase and Associates is Don Chase, 215-491-1700.
6. The controls scope was reviewed. The unit controllers shall be Siemens and the controls shall be factory mounted. Siemens will provide the controls and diagrams to the factory. The BAS controls sub-contractor must field mount the remote devises and wire back to the unit controller. The BAS controls subcontractor must provide the new hot water control valve and actuator. The MC shall install the valve and wire to the unit controller. The BAS subcontractor must complete the integration to the building BAS system and complete graphic upgrades. The only acceptable BAS controls sub-contractor is Siemens. The contact is Mr. David Anchuchie, 215-669-1429.
7. This is a one contract project.
8. The new shall fit on the existing curb. No curb adaptor shall be required.
9. The contractors were instructed that the unit heating piping must enter the bottom of the unit. This must be coordinated. Piping outside the unit, insulated with heat trace will **NOT** be acceptable.
10. A walk through on the roof was completed after the meeting.

The contractor must wire the duct detector to the unit controller to shut-down the unit upon the presence of smoke. The contractor if fully responsible for this operation.
