Mr. Copland advised the Board on the following:

## Motion: Approval of the Proposed 2014 - 2015 School Calendar

Ms. Boyle presented the following motion:

WHEREAS, the six participating school districts of the Bucks County Technical High School strive to establish a common school calendar; and

WHEREAS, the Board of School Directors reviewed the proposed calendar at the March 4, 2014 Public Work Session; and

WHEREAS, the proposed calendar was forwarded for comments to each of the employee bargaining groups.

NOW, THEREFORE, BE IT RESOLVED, that the Neshaminy Board of School Directors adopt the attached school calendar for the 2014 – 15 school year.

BE IT FURTHER RESOLVED, that the Board of School Directors specifically designate Section 1502 holidays: December 24 and 26, 2014; February 16, 2015; and April 2 and 3, 2015 as five official local school district holidays.

**BE IT FURTHER RESOLVED,** that students residing in Neshaminy School District be given first preference for program involvement and related program activities.

Mr. Sposato seconded the motion.

Mr. Rudy seconded the motion.

The Board unanimously approved said reports by a vote of nine ayes and zero nays.

Mr. Copeland asked for the Board's approval to enter into a contract with Executive Protective Services, LLC., for security services.

Mr. Congdon made a motion for the approval to enter into a contract with Executive Protective Services, LLC., for security services.

Mrs. Cummings seconded the motion.

Mr. Morris asked if the new director of security was available to answer some questions.

Mr. Copeland stated that he was not present.

Mr. Morris suggested the motion be tabled until the director could be present to answer questions.

The Board approved the motion by a vote of 7 ayes, 0 nays, and 2 abstentions, (Mr. Pirritano abstained for the reason being that an employee that works for him is also a part-time employee of Executive Protective Services, LLC., and Mr. Morris abstained for the reason being that the director of security was not present to answer questions.)

Mrs. Markowitz advised the Board that the total amount of Federal Grants is \$1,585,039.00.

#### Other Board Business

None.

#### **Public Comment**

Steve Rodos, retired, resident of Villages of Flowers Mill, questioned several items on the check register, e.g., charter schools, teen parenting program, payments to Source4Teachers, and tax collector bonds.

Leann Hartpence, resident of Langhorne, asked if a Board member can review the outcome of the Ad Hoc Committee meeting on March 17th in regard to the closing of Walter Miller Elementary School and the findings of the proposal about moving 5th grade to middle school. Ms. Hartpence also asked when the contract for the Administrators will come due.

Michelle Palmer, Neshaminy High School instructional aide, resident of Levittown, asked when Mr. Devlin will be briefing the Special Education Department regarding the possibility of moving the 5th grade to middle school.

### **Board Comment**

Mrs. Markowitz said that the teen parenting program is funded by a federal grant and there is no cost to the district. She also commented that the school district, the municipality, and the county has always paid for the bonds for the tax collectors every four years and all other expenses are their own responsibility.

Mr. Copeland said, in reply to Mr. Rodos' questions, that the concern about the funding to cyber charter schools is certainly a problem for Neshaminy as well as many districts, the 5th grade issue will be referred to a study group co-chaired by Dr. Hancock and Dr. George White, the administrators contract is up on June, 2015, Mr. Devlin will be addressing the issue at the Educational Development Committee meeting and there is an 85 per cent fill for the Source4Teachers with room for improvement.

Mr. Congdon stated that the Board has decided to cancel the hearing meetings on the closing of Walter Miller Elementary School at this time. He also said that the decision regarding moving 5th grade to middle school will take more time to explore. There will be meetings on the topic during the spring, summer and fall and he encouraged all interested parties to come to these meetings and present their input.

Mr. Pirritano recognized 2 long term employees of Neshaminy who recently resigned. He also stated that the next Ad Hoc Committee meeting will most likely be in the beginning of April.

Mr. Shubin encouraged everyone to attend the Technology meeting on March 19th at 7:00 p.m.

Mrs. Cummings thanked Mr. Mark Schmidt for his 18 years of service to Neshaminy as head football coach and physical education teacher and she reminded everyone that the Board Policy Meeting will be on March 25th at Maple Point Middle School.

Mr. Morris asked what committee would review the topic of moving 5th grade to middle school.

Mr. Congdon said it would be the Educational Development Committee, but there will also be meetings with the public for question and answer sessions during the spring, summer and fall.

Mr. Morris asked how the issue of moving 5th grade up came to be discussed at the Ad Hoc meetings and why were the school closing hearing meetings cancelled.

Mr. Congdon said the hearing meetings were cancelled because more time is needed to examine the process of closing an elementary school.

Mr. Pirritano added that the grade 5-8 model came up at the Ad Hoc meetings when the committee was examining the middle school usage.

Ms. Boyle stated that much of the dialog on important educational issues is discussed at committee meetings and she urged the public to attend those meetings to get information and to voice their opinions.

Ms. Boyle asked if indirect costs are associated with the grants.

Mrs. Markowitz said she will get back to her with the information.

### **Adjournment**

Mr. Congdon moved the meeting be adjourned and Mr. Sposato seconded the motion. The Board unanimously approved the motion. Mr. Condon adjourned the meeting at 7:59 p.m.
