1	I. GENERAL	The PA Child Protective Services Act was signed into law in 1975. This law	1	
2		was enacted to protect children from abuse, allow for the opportunity for	2	
3		healthy growth and development, and whenever possible, preserve and	3	
4		stabilize the family.	4	
5			5	
6		Child abuse, according to the Child Protective Services Law, includes	6	
7		any recent act or failure to act by a perpetrator which causes nonaccidental	7	
8		serious physical injury, or nonaccidental serious mental injury to a child	8	
9		under 18 years of age, sexual or sexual exploitation to a child under 18 years of	9	
10		age, and serious neglect. "Recent" is defined as an abusive act within two	10	
11		years from the date Childline is called. Sexual abuse has no time limit. Child	11	
12		abuse also includes any recent act, failure to act, or series of acts or failures	12	
13		to act by a perpetrator that creates an imminent risk of serious physical	13	
14		injury to or sexual abuse or exploitation of a child under 18 years of age.	14

16		A perpetrator of child abuse can be a child's parent, the person responsible for	16	
17		the welfare of a child such as a babysitter or day care staff person, an	17	
18		individual residing in the same home as the child who is at least 14 years of	18	
19		age, or a paramour of the child's parent regardless of whether or not they	19	
20		reside in the home. As a mandated reporter, you do not have to determine	20	
21		whether or not the person meets the definition of perpetrator in order to make	21	
22		the report.	22

24		Individuals who, in the course of their employment, occupation or practice of	24	
25		a profession, come into contact with children and have reasonable cause to	25	
26		suspect that a child under the care, supervision, guidance, or training of that	26	
27		person or of an agency, institution, organization or other entity with which	27	
28		that person is affiliated is a victim of child abuse are mandated to report.	28

30	II. SPECIFIC	In cases where serious physical, mental, sexual abuse or physical neglect is	30	
31	GUIDELINES	suspected, the guidance counselor, social worker, nurse, or administrator, as	31	
32		well as the mandated reporter must immediately contact Bucks County	32	
33		Children and Youth Services and Childline in Harrisburg. The phone	33

	Childline in Harrisburg, a CY-47 form (available through the school nurse) must be completed by the school nurse, or designee and filed with the Bucks	4 5
	County Children and Youth Services within 24 hours.	6 7
	School staff must also refer all cases of suspected physical abuse or physical	8
	neglect to the school nurse for examination.	9
	School staff (guidance counselor, social worker, nurse) must notify the	10 11
	building and district level administration that a call about suspected child	12
	abuse or neglect has been made to Children and Youth Services and Childline.	13 14
	In emergency circumstances when designated personnel are unavailable	14
	(e.g. after school hours), school staff are advised to use prudent judgment and	16
	contact the local police or the toll free Childline in Harrisburg and request direction.	17 18

	All documentation related to reports of abuse or neglect, including the CY-47	20
	form, must be maintained in the student's confidential file. If the report is determined to be unfounded by the investigating agency, then the reports are	21 22
	to be removed from the files and destroyed immediately by the appropriate	23
	administrators.	24

	• The victim child no longer needs to come directly before the mandated	27
	reporter in order for the reporter to be obligated to make a report. The	28
	mandated reporting requirements are expanded to require persons who have a reasonable cause to suspect – on the basis of medical, professional or other	29 30
	training and experience – that a child under the care, supervision, guidance	31
	or training of that person or of an agency, institution, organization or other	32
	entity with which that person is affiliated is a victim of child abuse.Mandated reporters are now obligated to report suspected child abuse	33 34
