THEORIES OF ACTION

Strand I

Student Achievement/Curriculum & Instruction

ACADEMIC CHOICE • IF we ensure that instruction provides academic choice, THEN Neshaminy students will be more engaged and invested in their own learning.

Example activities include but are not limited to:

- Incorporate different pathways to graduation to meet graduation requirements
- Explore choices for middle school specials
- Expand course offerings of all secondary grade levels
- Focus on students in the 'academic middle'
- Provide for more project-based learning opportunities
- Focus counseling program on career exposure (K-12) (e.g., career investigation fairs)

QUALITY ASSESSMENT • IF we create an assessment and grading system that is consistent and reflective of student achievement and understanding, THEN students will be able to use this formative feedback in order to advance their learning and educators will be able to use the data to adjust instruction to best meet the needs of students.

Example activities include but are not limited to:

- Eliminate scoring that works counter to learning e.g., giving a '0'
- Provide opportunity for students to demonstrate mastery in a variety of ways
- Ensure that there is balance in the type of assignments
- Incorporate multiple types of assessments portfolios, projects
- Regularly give students 'second chance learning' opportunities
- Review grading policies and practices (K-12) including homework – to ensure these are consistent with this theory of action

Strand II

Student-centered and Community-focused

COMMUNITY ACTIVITIES • IF we involve students in authentic, community-based activities, THEN they will build a foundation for further action as productive members of society.

Example activities include but are not limited to:

- Coordinate and add to the variety of service learning/community service opportunities
- Incorporate true internships as a vehicle for learning
- Foster student involvement with community partnerships
- Develop an evening school that brings together staff, students, and others in the community as teachers and participants
- Promote formal mentoring programs community programs and school-to-school student mentoring

IMPROVED COMMUNICATION • IF we

improve the variety and quality of our communication vehicles, THEN we will better connect our students, parents and the broader school community and enrich learning opportunities.

Example activities include but are not limited to:

- Develop a comprehensive community educational resources database
- Provide evening access to resources, academic and social
- Improve and advertise a single access portal to NSD online systems
- Assist families in their efforts to gain computer/internet access in the home

SOCIAL/EMOTIONAL SUPPORT • IF we provide social and emotional support systems for our students, THEN they will meet with greater academic success.

Example activities include but are not limited to:

- Bring in more school-based mental health services for a wider cross-section of the student body
- Develop a variety of student support groups available day and evening
- Incorporate systemic social/emotional programs (e.g., Habits of Mind curriculum)

Strand III

Financial Responsibility and Fiscal Resiliency

PROGRAM EVALUATION • IF we regularly evaluate the effectiveness of individual programs, THEN we can better channel appropriate resources.

Example activities include but are not limited to:

- Evaluate the efficiency of resources (including contracted services)
- Eliminate redundancy of services
- Conduct Program Quality Reviews (PQRs) to help assess programs
- Evaluate high school elective offerings

ALTERNATIVES • IF we increase or develop alternative methods for the delivery of instruction, THEN we will increase the available resources for all students.

Example activities include but are not limited to:

- Add in-house cyber school/classes
- Evaluate delivery of summer school programming brick/mortar vs. cyber
- Explore increased opportunities for students to earn college credits (e.g., dual credit programs)
- Partner with businesses or hospitals to establish community service and internship opportunities
- Create a district parent volunteer database for subject experts to support instruction

NEW REVENUE • IF we pursue new revenue, THEN we will be able to create and offer new learning opportunities.

Example activities include but are not limited to:

What's Next... Implementation Teams

We are seeking individuals to join our Implementation Teams, a new component of our strategic planning process. There will be one Implementation Team for each of the three 'strands' of the new plan:

Strand I: Student Achievement/Curriculum & Instruction
Strand II: Student-centered and Community-focused
Strand III: Financial Responsibility and Fiscal Resiliency

It is expected that these groups may meet as frequently as monthly; the suggested start time for the meetings will be 4:00 p.m. Each team can alter the frequency and time of the meetings with agreement among team members.
