**TITLE: Acceptable Use of the Computers, Network, Internet,
Electronic Communications and Technical Services Policy**

NESHAMINY SCHOOL DISTRICT

1	I. Purpose	The Neshaminy School District (NSD) provides employees, students, and guests (users)	1
2		with access to the District's electronic communication systems and network,	2
3		which includes Internet access, whether wired or wireless, or by any other means.	3
4		Guests include, but are not limited to, visitors, workshop attendees, volunteers,	4
5		independent contractors, adult education staff, students, and board members.	5
6			6
7		Computers, network, Internet, electronic communications and Technical Services	7
8		(collectively "NIS") provide vast, diverse and unique resources. The Board of School	8
9		Directors will provide access to the District's NIS systems for users if there is a specific	9
10		District-related purpose to access information and research; to collaborate to facilitate	10
11		learning and teaching; and to foster the educational purpose and mission of the	11
12		District.	12
13			13
14		For users, the District's NIS systems must be used for education-related purposes and	14
15		performance of District job duties. Incidental personal use of school computers is	15
16		permitted for employees so long as such use does not interfere with the employee's job	16
17		duties and performance, with system operations, or with other system users. Personal	17
18		use must comply with this policy and all other applicable District policies, procedures	18
19		and rules contained in this policy, as well as Internet service provider ("ISP") terms,	19
20		local, state and federal laws and must not damage the District's NIS systems.	20
21			21
22		Students may only use the NIS systems for educational purposes. At the same time,	22
23		personal technology devices brought onto the District's property, or to District events,	23
24		or connected to the District's network, that the District reasonably believes contain	24
25		District information or contain information that violates a District policy, or contain	25
26		information/data that the District reasonably believes involves a criminal activity may	26
27		be legally accessed to insure compliance with this policy, other District policies, and to	27
28		comply with the law. Users may not use their personal electronic devices, including	28
29		computers to connect to the District's intranet, Internet or any other NIS system	29
30		unless approved by the Director of Technology and/or designee.	30
31			31
32		The District intends to strictly protect its NIS systems against numerous outside and	32
33		internal risks and vulnerabilities. Users are important and critical players in protecting	33
34		these District assets and in lessening the risks that can destroy these important and	34

2		critical assets. Consequently, users are required to fully comply with this policy, and to	2
3		immediately report any violations or suspicious activities to the Director of Technology	3
4		and/or building lab aide for staff; and to teacher, guidance counselor, and/or	4
5		building principal. Conduct otherwise will result in actions further described in	5
6		Section VI – Guidelines – Consequences for Inappropriate, Unauthorized and Illegal	6
7		Use, found in the last section of this policy, and provided in relevant District policies.	7

9	II. Definitions	Child Pornography – Under Federal law, any visual depiction, including any	9
10		photograph, film, video, picture, or computer or computer-generated image or picture,	10
11		whether made or produced by electronic, mechanical, or other means, of sexually	11
12		explicit conduct, where:	12
13		a. the production of such visual depiction involves the use of a minor	13
14		engaging in sexually explicit conduct;	14
15		b. such visual depiction is a digital image, computer image, or computer-	15
16		generated image that is, or is indistinguishable from, that of a minor	16
17		engaging in sexually explicit conduct; or	17
18		c. such visual depiction has been created, adapted, or modified to appear	18
19		that an identifiable minor is engaging in sexually explicit conduct.	19
20		Under Pennsylvania law, any book, magazine, pamphlet, slide, photograph, film,	20
21		videotape, computer depiction or other material depicting a child under the age of 18	21
22		years engaging in a prohibited sexual act or in the simulation of such act is prohibited.	22
23			23
24		Computer – Includes any District owned, leased or licensed or user owned	24
25		personal hardware, software, or other technology used on District premises or at	25
26		District events, or connected to the District network, containing District programs or	26
27		District or student data (including images, files, and other information) attached or	27
28		connected to, installed in, or otherwise used in connection with a computer. Computer	28
29		includes, but is not limited to, District and users': desktop, notebook, PowerBook,	29
30		tablet PC or laptop computers, printers, facsimile machine, cables, modems, and other	30
31		peripherals; specialized electronic equipment used for students' special educational	31
32		purposes; global Positioning System (GPS) equipment; personal digital assistants	32
33		(PDAs); iPods, IPADS, MP3 players; cell phones, with or without Internet access and/	33
34		or recording and/or camera/video and other capabilities and configurations,	34
35		telephones, mobile phones, or wireless devices, two-way radios/telephones; beepers;	35
36		paging devices, laser pointers and attachments, and any other such technology	36
37		developed.	37
38			38
39		Electronic Communications Systems – Any messaging, collaboration, publishing,	39
40		broadcast, or distribution system that depends on electronic communications resources	40
41		to create, send, forward, reply to, transmit, store, hold, copy, download, display, view,	41
42		read, or print electronic records for purposes of communication across electronic	42
43		communications network systems between or among individuals or groups, that is	43
44		either explicitly denoted as a system for electronic communications or is implicitly used	44

2	for such purposes. Further, an electronic communications system means any wire,	2
3	radio, electromagnetic, photo-optical or photo-electronic facilities for the transmission	3
4	of wire or electronic communications, and any computer facilities or related	4
5	electronic equipment for the electronic storage of such communications. Examples	5
6	include, without limitation, the Internet, intranet, electronic mail services, GPS, PDAs,	6
7	facsimile machines, cell phones with or without Internet access and/or electronic mail	7
8	and/or electronic mail and/or recording devices, cameras/video, and other	8
9	capabilities or configurations.	9
10		10
11	Educational Purpose – Includes use of the NIS systems for classroom activities,	11
12	professional or career development, and to support the District’s curriculum, policy	12
13	and mission statement.	13
14		14
15	Harmful to Minors – Under Federal law, any picture, image, graphic image file or	15
16	other visual depictions that:	16
17	a. taken as a whole, with respect to minors, appeals to the prurient interest	17
18	in nudity, sex, or excretion;	18
19	b. depicts, describes, or represents in a patently offensive way with respect	19
20	to what is suitable for minors, an actual or simulated sexual act or sexual	20
21	content, actual or simulated normal or perverted sexual acts, or lewd	21
22	exhibition of the genitals; and	22
23	c. taken as a whole, lacks serious literary, artistic, political, educational or	23
24	scientific value as to minors.	24
25	Under Pennsylvania law, any description or representation in whatever form, of	25
26	nudity, sexual conduct, sexual excitement, or sadomasochistic abuse, when it:	26
27	a. predominantly appeals to the prurient, shameful, or morbid interest of	27
28	minors; and	28
29	b. is patently offensive to prevailing standards in the adult community as a	29
30	whole with respect to what is suitable for minors; and	30
31	c. taken as a whole, lacks serious literary, artistic, political, educational or	31
32	scientific value for minors.	32
33		33
34	Incidental Personal Use – Incidental personal use of school computers is permitted	34
35	for employees so long as such use does not interfere with the employee’s job duties	35
36	and performance, with system operations, or with other system users. Personal use	36
37	must comply with this policy and all other applicable District procedures, rules	37
38	contained in this policy, school rules and directives, as well as ISP terms, local, state	38
39	and federal laws and must not damage the District’s NIS systems.	39
40		40
41	Minor – For purposes of compliance with the Children’s Internet Protection Act	41
42	(“CIPA”), an individual who has not yet attained the age of seventeen. For other	42
43	purposes, minor shall mean the age of minority as defined in the relevant law.	43

2		Obscene – Under Federal law, analysis of the material meets the following	2
3		elements:	3
4		a. whether the average person, applying contemporary community	4
5		standards, would find that the material, taken as a whole,	5
6		appeals to the prurient interest;	6
7		b. whether the work depicts or describes, in a patently offensive way, sexual	7
8		conduct specifically designed by the applicable state or federal law to be	8
9		obscene; and	9
10		c. whether the work taken as a whole lacks serious literary, artistic, political,	10
11		educational, or scientific value.	11
12		Under Pennsylvania law, analysis of the material meets the following elements:	12
13		a. the average person, applying contemporary community standards, would	13
14		find that the material, taken as a whole, appeals to the prurient interest;	14
15		b. the subject matter depicts or describes in a patently offensive way, sexual	15
16		conduct described in the law to be obscene; and	16
17		c. the subject matter, taken as a whole lacks serious literary, artistic,	17
18		political, educational or scientific value.	18

20		Sexual Act and Sexual Contact – As defined at 18 U.S.C. § 2246(3), 18 Pa.C.S.A. § 5903.	20

22		Technology Protection Measure(s) – A specific technology that blocks or filters	22
23		Internet access to visual depictions that are obscene, child pornography or harmful	23
24		to minors.	24
25			25
26		Visual Depictions – Undeveloped film and videotape and data stored on	26
27		computer disk or by electronic means which is capable of conversion into a visual	27
28		image but does not include mere words.	28
29			29
30	III. Authority	Access to the District's NIS systems through school resources is a privilege, not a	30
31		right. These, as well as the user accounts and information, are the property of the	31
32		District, which reserves the right to deny access to prevent further unauthorized,	32
33		inappropriate or illegal activity, and may revoke those privileges and/or administer	33
34		appropriate disciplinary action. The District will cooperate to the extent legally	34
35		required with ISP, local, state and federal officials in any investigation concerning or	35
36		related to the misuse of the NIS systems.	36
37			37
38		It is often necessary to access user accounts, including but not limited to email boxes,	38
39		network folders, and hard drives on the District-assigned laptop or desktop, in order to	39
40		perform routine maintenance and security tasks; system administrators have the right	40
41		to access by interception, and the stored communication of user accounts for any	41
42		reason in order to uphold this policy and to maintain the system. Users have no	42
43		privacy expectation in the contents of their personal files or any of their use of the	43
44		District's NIS systems. The District reserves the right to monitor, track, log and access	44

2	NIS systems use and to monitor and allocate fileserver space.	2
3		3
4	The District reserves the right to restrict access to any Internet sites or functions it	4
5	may deem inappropriate through general policy, software blocking or online server	5
6	blocking. Specifically, the District operates and enforces technology protection	6
7	measure(s) that block or filter online activities of minors on its computers used and	7
8	accessible to adults and students so as to filter or block inappropriate matter on the	8
9	Internet. Inappropriate matter includes, but is not limited to, visual, graphic, text and	9
10	any other form or obscene, sexually explicit, child pornographic, or other material that	10
11	is harmful to minors, hateful, illegal, defamatory, lewd, vulgar, profane, rude,	11
12	inflammatory, threatening, harassing, discriminatory (as it pertains to race, color,	12
13	religion, national origin, gender, marital status, age, sexual orientation, political beliefs,	13
14	receipt of financial aid, or disability), violent, bullying, terroristic, and advocates the	14
15	destruction of property. Measures designed to restrict adults' and minors' access to	15
16	material harmful to minors may be disabled to enable an adult or student to access	16
17	bona fide research, not within the prohibitions of this policy, or for another lawful	17
18	purpose. No person may have access to material that is illegal under federal or state	18
19	law. Expedited review and resolution of a claim that the policy is denying a student or	19
20	adult to access material will be enforced by an administrator, supervisor, or their	20
21	designee upon the receipt of written consent from a parent or guardian of a student,	21
22	and upon the written request from an adult.	22
23		23
24	The District has the right, but not the duty, to monitor, track, log, access and/or	24
25	report all aspects of its computer information, technology and related systems of all	25
26	users and of any user's personal computers, network, Internet, electronic	26
27	communication systems, and media that they bring onto District property, or to	27
28	District events, that were connected to the District network, which contained District	28
29	programs or District or student data (including images, files, and other information),	29
30	all pursuant to the law, in order to insure compliance with this policy and other	30
31	District policies, to protect the District's resources, and to comply with the law.	31
32		32
33	The District reserves the right to restrict or limit usage of lower priority NIS systems	33
34	and computer uses when network and computing requirements exceed available	34
35	capacity according to the following priorities:	35
36	a. Highest – uses that directly supports the education of students.	36
37	b. Medium – uses that indirectly benefit the education of the students.	37
38	c. Lowest – uses that include reasonable and limited educationally-related	38
39	interpersonal communications.	39
40	d. Forbidden – all activities in violation of this policy.	40
41		41
42	The District additionally reserves the right to:	42
43	a. Determine which NIS systems' services will be provided through District	43
44	resources. The Director of Elementary and Secondary Education, the	44

2		Director of Technology, and the Director of Curriculum, Assessment, and	2
3		Instruction will jointly determine this.	3
4		b. Determine the types of files that may be stored on District file servers and	4
5		computers. The Director of Technology will determine this.	5
6		c. View and monitor network traffic, file server space, processor, and system	6
7		utilization, and all applications provided through the network and	7
8		communications systems, including e-mail and other electronic	8
9		communications. The Director of Technology will perform this.	9
10		d. Remove excess e-mail or files taking up an inordinate amount of fileserver	10
11		disk space after a reasonable time. The Director of Technology will	11
12		perform this as authorized by the building principal or supervisor.	12
13		e. Revoke user privileges, remove user accounts, or refer to legal authorities	13
14		when violation of this and any other applicable District policies occur or	14
15		state or federal law is violated, including, but not limited to, those	15
16		governing network use, copyright, security, privacy, employment, data	16
17		breaches, and destruction of District resources and equipment. The	17
18		Director of Technology will perform this, with authorization from the	18
19		appropriate Business Office Administrator, building principal, or	19
20		employee supervisor.	20
21			21
22	IV.	Due to the nature of the Internet as a global network connecting thousands of	22
23	Responsibility	computers around the world, inappropriate materials, including those which may be	23
24		defamatory, discriminatory (as it pertains to race, color, religion, national origin,	24
25		gender, marital status, age, sexual orientation, political beliefs, receipt of financial aid,	25
26		or disability), inaccurate, obscene, sexually explicit, lewd, vulgar, rude, harassing,	26
27		violent, inflammatory, threatening, terroristic, hateful, bullying, profane, pornographic,	27
28		offensive, or illegal, can be assessed through the network and electronic	28
29		communications systems. Because of the nature of the technology that allows the	29
30		Internet to operate, the District cannot completely block access to these resources.	30
31		Accessing these and similar types of resources may be considered an unacceptable use	31
32		of school resources and will result in actions explained further under Consequences	32
33		for Inappropriate, Unauthorized and Illegal Use , found in the last section of this	33
34		policy and as provided in relevant District policies.	34
35			35
36		Users must be capable and able to use the District's NIS systems, and software	36
37		relevant to their responsibilities. In addition, users must follow the "best practices"	37
38		guidelines developed by the Director of Technology, practice proper etiquette, District	38
39		ethics, and agree to the requirements of this policy.	39
40			40
41	V. Delegation	The Director of Technology and/or designee will serve as the coordinator to	41
42	of Responsibility	oversee the District's NIS systems and will work with other regional or state	42
43		organizations as necessary, to educate users, approve activities, provide leadership	43
44		for proper training for all users in the use of the NIS systems and the requirements of	44

2		this policy, establish a system to insure adequate supervision of the NIS systems,	2
3		maintain executed user agreements, and interpret and enforce this policy.	3
4			4
5		The Director of Curriculum and Instruction or designee shall develop and	5
6		implement administrative regulations that ensure students are educated on network	6
7		etiquette and other appropriate online behavior, including but not limited to:	7
8		a. Interaction with other individuals on social networking web sites and in	8
9		chat rooms.	9
10		b. Cyberbullying awareness and response.	10
11			11
12		The Director of Technology and/or designee will establish a process for setting-up	12
13		individual and class accounts, develop "best practices" guidelines for users to manage	13
14		their e-mail boxes and network folders, set quotas for disk usage on the system,	14
15		establish a Policy and Schedule for the retention and destruction of District	15
16		electronically stored information, and establish the District virus protection process.	16
17			17
18		Unless otherwise denied for cause, student access to the NIS systems resources	18
19		shall be through supervision by the professional staff. Administrators, teachers and	19
20		staff have the responsibility to work together to help students develop the skills and	20
21		judgment required to make effective and appropriate use of the resources. All users	21
22		have the responsibility to respect the rights of all other users within the District and	22
23		District NIS systems, and to abide by the rules established by the District, its ISP, local,	23
24		state and federal laws.	24

26	VI. Guidelines	Access to the NIS Systems	26
27		a. NIS system user accounts will be used only by authorized owners of the	27
28		accounts for authorized purposes.	28
29		b. An account will be made available according to a procedure developed by	29
30		appropriate District authorities and performed by the Director of	30
31		Technology, or designee.	31
32		c. Types of Services include, but are not limited to:	32
33		1) World Wide Web. District employees, students, and guests will have	33
34		access to the Web through the District's NIS systems as needed.	34
35		2) E-Mail. District employees may be assigned individual e-mail	35
36		accounts for work related use, as needed. Students may be assigned	36
37		individual e-mail accounts, as necessary, by the Director of	37
38		Technology and/or designee, and at the recommendation of the	38
39		teacher who will also supervise the students' use of the e-mail service.	39
40		3) Guest Accounts. Guests may receive an individual account with the	40
41		approval of the Director of Technology and/or designee if there is a	41
42		specific District-related purpose requiring such access. Use of the NIS	42
43		systems by a guest must be specifically limited to the District-related	43
44		purpose and comply with this policy and all other District policies,	44

2		procedures and rules, as well as Internet Service Provider ("ISP")	2
3		terms, local, state and federal laws and may not damage the District's	3
4		NIS systems. An agreement between the District and a Guest, and a	4
5		parental signature will be required if the Guest is a minor.	5
6		4) Web 2.0 Second Generation Web-based Services. Certain District	6
7		authorized Second Generation Web-based services, such as social	7
8		networking sites, wikis, podcasts, RSS feeds, social software,	8
9		folksonomies and collaboration tools that emphasize online	9
10		educational collaboration and sharing among users may be permitted	10
11		by the District, however, such use must be approved by the	11
12		Director of Curriculum, Assessment and Instruction, or designee,	12
13		followed by training authorized by the District. Users must comply	13
14		with this policy, as well as any other relevant policy, regulations	14
15		or rules during such use.	15

27		Parental Notification and Responsibility	27
28		The District will keep this policy posted on its website. This policy contains	28
29		restrictions on accessing inappropriate material. There is a wide range of material	29
30		available on the Internet, some of which may not be fitting with the particular values	30
31		of the families of the students. It is not practically possible for the District to monitor	31
32		and enforce a wide range of social values in student use of the Internet. Further, the	32
33		District recognizes that parents bear primary responsibility for transmitting their	33
34		particular set of family values to their children. The District will encourage parents to	34
35		specify to their child(ren) what material is and is not acceptable for their child(ren) to	35
36		access through the District's NIS system. Parents are responsible for monitoring their	36
37		children's use of the District's NIS system when they are accessing the systems from	37
38		outside of the District.	38
39			39
40		School District Limitation of Liability	40
41		The District makes no warranties of any kind, either expressed or implied, that the	41
42		functions or the services provided by or through the District's NIS systems will be	42
43		error-free or without defect. The District does not warrant the effectiveness of	43
44		Internet filtering. The electronic information available to users does not imply	44

2		endorsement of the content by the District, nor is the District responsible for the	2
3		accuracy or quality of the information obtained through or stored on the NIS systems.	3
4		The District shall not be responsible for any damage users may suffer, including but	4
5		not limited to, information that may be lost, damaged, delayed, misdelivered, or	5
6		unavailable when using the computers, network and electronic communications	6
7		systems. The District shall not be responsible for material that is retrieved through the	7
8		Internet, or the consequences that may result from them. The District shall not be	8
9		responsible for any unauthorized financial obligations, charges or fees resulting from	9
10		access to the District's NIS systems. In no event shall the District be liable to the user	10
11		for any damages whether direct, indirect, special or consequential, arising out of the	11
12		use of the NIS systems.	12
13			13
14		Prohibitions	14
15		The use of the District's NIS systems for illegal, inappropriate, unacceptable, or	15
16		unethical purposes by users is prohibited. Such activities engaged in by users are	16
17		strictly prohibited and illustrated below. The District reserves the right to determine if	17
18		any activity not appearing in the list below constitutes an acceptable or unacceptable	18
19		use of the NIS systems.	19
20		These prohibitions are in effect any time District resources are accessed whether on	20
21		District property, when using mobile computing equipment, telecommunication	21
22		facilities in unprotected areas or environments, directly from home, or indirectly	22
23		through another ISP, and if relevant, when an employee or student uses their own	23
24		equipment.	24
25		Students are prohibited from visually possessing and using their personal computers	25
26		on District premises and property (including but not limited to buses and other	26
27		vehicles), at District events, or through connection to the District NIS systems, unless	27
28		expressed permission has been granted by a teacher or administrator, who will then	28
29		assume the responsibility to supervise the student in its use, or, unless an IEP team	29
30		determines otherwise, in which case, an employee will supervise the student in its use.	30
31		Students at the high school level are permitted to use their cell phones during the	31
32		change of classes. Thus, in general, students are prohibited from using cell phones,	32
33		with or without Internet access and/or recording and/or camera/video and other	33
34		capabilities and configurations.	34
35		Cameras, and the like, may not be used to take images of others, transfer them, or place	35
36		them on websites without the consent of the building principal. Students who are	36
37		performing volunteer fire company, ambulance or rescue squad functions, or need	37
38	SC § 3-1317.1(b)	such a computer due to their medical condition, or the medical condition of a member	38
39		of their family, with notice and the approval of the school administrator may qualify	39
40		for an exemption of this prohibition.	40
41		a. General Prohibitions	41
42		Users are prohibited from using District NIS systems to:	42
43		▪ Communicate about non-work or non-school related	43
44		communications using District-assigned e-mail accounts.	44

3		○ District employees may be allowed to access their personal	3
4		ISP e-mail accounts through the Internet, provided it does	4
5		not interfere with their job responsibilities and that	5
6		it does not interfere with other employee job-related use	6
7		of computer and network resources.	7
8		○ Students may be allowed to access their personal ISP	8
9		e-mail accounts through the Internet, provided it is not	9
10		done on class time and that it does not deny other	10
11		students of computer and network resources.	11
12		○ Examples of personal ISP accounts are AOL, Comcast,	12
13		Verizon, Hotmail, Yahoo and Gmail.	13
14		▪ Send, receive, view, download, access or transmit material that is	14
15		harmful to minors, indecent, obscene, pornographic, child	15
16		pornographic, terroristic, or advocates the destruction of property.	16
17		▪ Send, receive, view, download, access or transmit inappropriate	17
18		matter and material likely to be offensive or objectionable to	18
19		recipients including, but not limited to, that which may be	19

- NSD reserves the right to access user accounts, including but not limited to email boxes, network folders, and hard drives on District-assigned laptops or desktop computers, in order to perform routine maintenance and security tasks.
- Access to all data on, taken from or compiled using District computers is subject to inspection and discipline.
- Staff may not:
 - post personal communications in public forum without the original author's prior consent
 - install, distribute, reproduce or use copyrighted software on District computers, or copy District software to unauthorized computer systems
 - install computer hardware, peripheral devices, network hardware or system hardware
 - access, interfere, possess, or distribute confidential or private information
 - post anonymous messages
 - bypass or attempt to bypass Internet filtering software by any methods including, but not limited to, the use of proxies
 - acquire or attempt to acquire passwords of another or the misuse of another user's name and password
 - use a computer that has been logged-in under another user's name
 - disable or circumvent any District security, program or device
 - scan the NSD system for security vulnerabilities
 - load, download or use unauthorized games, programs, files or other electronic media, including, but not limited to, downloading music files, movies and video clips
 - use the network to disrupt the work of other users
 - use the network to access obscene or pornographic material or inappropriate language or profanity on the network
 - use the network for commercial or for profit purposes, product advertisement or political lobbying

Sanction and Violations

The network user shall be responsible for damages to the equipment, systems and software or other resources resulting from deliberate or willful acts. These may be reported to law enforcement.

Violations may result in a limited or immediate total loss of right to the District's technology.

Additional disciplinary action may be determined at the District level in line with the Employee Handbook and the District's Code of Conduct.
