Dear Neshaminy Resident:

Enclosed are your application form and instructions for The Volunteer Firefighter Assistance Program. It has been the intention of the Neshaminy Board of School Directors to incentivize citizens who volunteer with a service tax credit. We thank you for your service and for keeping our communities safe.

This program is entering its Second year. Since 2023 rebates totaling approximately \$40,000 have been paid by the school district, with over 50 volunteers participating last year. We hope that the amount for which you qualify helps to partially overcome today's high cost of living. Rebates are based on service percentage. To qualify:

- 1. You must respond to 25% or more emergency calls in one year
- 2 Your rebate property must be your **primary residence**.
- 3. You must complete the application in its entirety and attach a paid school bill tax receipt

The school district will make every effort to send your rebate within eight-twelve weeks of <u>receipt</u> of your application. However, our success in this area will depend on your cooperation by providing all the necessary information and substantiating documents, and by filing your claim as early as possible. In addition to delaying all rebates, incomplete applications have the potential of not meeting the deadline of June 15.

Please call us if you have not received a rebate or correspondence from us after twelve weeks of sending us your application. If you have any questions about our rebate program, or if you require assistance in completing the form, you may call either your local tax collector or the Neshaminy School District Business Office at 215-809-6520.
